

(1) Public Access

- We make publications fully, permanently and immediately available to the public - there is NO embargo period.
- Our books are published in hardback, paperback and ebook editions, but we also publish free digital editions of every title in PDF and HTML formats that can be read via our website, downloaded, reused or embedded anywhere.
- Titles are distributed to various metadata distributors and aggregators immediately after publication. Access our Distribution Guidelines [here](#).
- We voluntarily and periodically contribute with metadata to open initiatives, such as Merlot, Open Textbooks Platform, the DOAB or OAPEN.
- Member Libraries can upload any digital edition of an OBP title to the library's digital repository or ebook collection to keep permanently. Thus, even if a library decides to terminate its membership, it will maintain permanent and uninterrupted access to all titles accessible during the membership period.
- After publication authors can upload the free-to-read edition of their work on their website, institutional repository, social media page, blog and any other digital platform.

(2) Book Processing Charges (BPC)

- We do not require authors to pay an Open Access fee for publication.
- We encourage those who are able to apply for grants from their university and elsewhere to do so, in order to defray the costs of publishing their book and enable us to accept more authors who do not have funding, but the decision about whether or not we will accept a manuscript for publication depends entirely on the outcome of our peer review process and not on the availability or otherwise of funding. (3) Copyright and use

- All our titles are published using Creative Commons licences. These licences mean that authors are in full control of their own copyright, and can choose how their work is used by other people.
- We recommend the Creative Commons Attribution license (CC BY) which allows others to copy, distribute, display and perform the author's copyrighted work, but ensures that they must give you full credit. All the same rules of plagiarism and citation apply to works under this licence. Details of the alternative Creative Commons licences available can be found [here](#).
- After publication authors can upload the free-to-read edition of their work on their website, social media page, blog and any other digital platform.

(4) Business Model

- Open Book Publishers, founded in 2008, is already the biggest independent open access academic publisher of monographs in the UK and amongst the leaders in the English-speaking world.
- Open Book Publishers is a not-for-profit Social Enterprise run by academics who are committed to making high-quality and prize-winning research available to all, and are now the hub of choice for a rapidly increasing international network of scholars who believe that it is time for academic publishing to become fairer, faster and more accessible.
- As founder members of the ScholarLed consortium of academic-led Open Access presses, and part of the COPIM project, Open Book Publishers is in the process of developing open-source infrastructure to enable other Open Access publishers to grow and flourish. We are working towards a future in which there will be no barriers to the access or production of knowledge. We are also founding members of the [Open Access Books Network](#) where Editor and Outreach Coordinator, Lucy Barnes, is an OABN coordinator.
- At Open Book Publishers we are not only interested in open access publications; we believe the software that supports open access books should be free and Open Source, too. We are committed to reducing technological barriers that make it difficult for new Open Access initiatives to reach traditional markets by making our own technology more easily accessible for other publishers and new initiatives to adopt. We are committed to releasing all our software as Open Source and have launched a GitHub account (<https://github.com/OpenBookPublishers>) to host the growing content of Open Source software we are developing. We intend to have our complete publishing operating systems available as Open Source content on our GitHub account and to bring wider and long-term benefits to a host of educational projects.
- Mixed business model: revenue from the sale of affordably priced digital and paper copies alongside our Open Access editions; our innovative and long-standing Library Membership Programme; and the grant funding that some authors are able to source to support the publication of their books.
 - Sales: we offer reasonably priced paperback, hardback and ebook editions.
 - Grants and donations: we do not impose charges to publish with us, but we do encourage authors if they can to apply for grants to defray production costs—this enables us to take on more books that do not have any grant income attached. The availability or otherwise of grant money has no impact on our publication decisions, which are entirely dependent on the outcome of the peer-review process. We have also included donations given directly to OBP to facilitate our work (i.e. not associated with any particular title).
 - [Library Membership programme](#): our Library Members pay an annual fee to support our work, in return for a range of reader-targeted benefits for members of the university. This innovative programme has been in place since 2015 and it has proven popular—we currently have [over 250 member libraries from all over the world](#). Many libraries see their

membership as an investment in the future of Open Access and as part of the transition away from expensive, closed-access models of research dissemination. We are proud to have their support in making research freely available for everyone.

- Title production charges: While we do not impose publishing costs on authors, we are sometimes asked by authors to provide additional services such as image-processing and indexing, for which we charge separately.

(5) Discoverability

- OBP titles are preserved in the UK legal deposit libraries at the British Library, OpenEdition, Google Books, and the Internet Archive.
- We provide rich and openly available metadata, improving discoverability and reuse. Our metadata can be retrieved in multiple formats from [Thoth](#).
- Our titles are available through the major retail outlets and distribution channels (including Amazon, Apple iBook store, Google Play, Barnes & Noble, Bertram Books, Blackwells, CNKI Beijing, EBSCO, ProQuest, JSTOR and YBP). [Access our Distribution Guidelines](#) with a full list of the platforms to which we distribute. We also distribute our titles on a monthly basis to the Library of Congress, CHOICE, and The Conversation.
- We voluntarily contribute with metadata to open initiatives, such as Merlot, Open Textbooks Platform, the DOAB, OAPEN and more even when not funder-required.
- Our titles are available via Print-on-Demand in paperback and hardback (meaning they are never out of print) and can be ordered from any country.
- We provide MARC records for Member libraries to list our books in their catalogues, as well as automatic metadata distribution to Crossref and publication metadata to wholesale and eBook distributors.
- Books are published using a permanent identifier (DOI).

(6) Accessibility

Since June 2020, all our EPUB editions have been created in line with [WCAG 2.0 AA guidelines](#). We format our books in accessible ways, e.g. we do not use columns as a standard layout and any tables are carefully formatted. We have improved navigation for text-to-speech software and we create HTML that produces a clearly structured text in which elements are specialised according to their function. We have also added metadata that tells a reader using accessibility aids what type of content is included, and whether or not the book is accessible for them. All our images have full captions, and most books published since summer 2022 include alt-text for images.

Our EPUB editions are made accessible thanks to an [Open Source plug-in](#) created by Luca Baffa and maintained by OBP, which can be freely accessed on GitHub and used by anyone.

We also supply all our EPUB editions to [RNIB Bookshare](#). Bookshare members can acquire accessible editions that enable them to:

- Listen to books with high quality text-to-speech voices
- Hear and see highlighted words on screen
- Read with digital braille or enlarged fonts
- Create physical braille or large print
- Read directly from your Internet browser
- And more!

Membership of RNIB Bookshare is free to educators in the UK who are supporting print-disabled learners and allows you to download curriculum resources, including textbooks and accessible images. There is a small charge for schools outside of the UK supporting print-disabled learners. [Find out more](#).

Future plans

Accessibility in all its forms is important to OBP. As a small press with limited resources, there is always more we would like to be able to do to increase the accessibility of our books. For the next stage of our development in this area, we will prioritise:

Making all editions text-to-speech readable. At present, we have focused mainly on our EPUB editions but we would like to make sure that our HTML, XML and PDF editions are as accessible as possible too. As with all our developments, any [software](#) we create to facilitate this will be Open Source for others to use and adapt freely.

Open Access and accessibility

Finally, a reminder that all our books are Open Access and published under a CC licence, which means they can be modified according to the terms of the licence. If anybody with the time and the expertise would like

to take advantage of the open licence to create more accessible editions of any of our books (and, even better, to let us know that you have done so) we would be delighted.

(7) Publishing Practices

- We ensure that we do not need to charge authors a mandatory Open Access fee thanks to our sustainable mixed model of funding, including revenue from the sale of affordably priced digital and paper copies alongside our Open Access editions; our innovative and long-standing Library Membership Programme; and the grant funding that some authors can source to support the publication of their books.
- Depending on several factors including, for example, the length of the manuscript and number of images, it typically costs us £5,000 to produce and market a book. If a book is unusually lengthy or contains a very large number of images, we may charge a production fee to cover the extra costs, as detailed in Appendix Three of our Authors' Guide.
- We provide information on possible sources of publishing grants for Open Access books and support our authors throughout the application process. For more information on available grants and how to apply, see our Authors' Guide.
- Authors, or at least the corresponding author, are identified with ORCIDs.
- All books published by OBP can be submitted for university research assessments. In the UK, our books have been submitted for the UK REF assessment exercise, and UKRI has indicated that for the REF-after-REF 2021, there is likely to be an Open Access mandate for monographs, chapters and edited collections.
- Our books are regularly reviewed in publications, academic journals and scholarly blogs including *The Times Literary Supplement*, *Times Higher Education*, *Essays in Criticism*, *Modern Language Review*, *Choice Review*, *Romanticism*, *The Year's Work in English Studies* / *The Year's Work in Critical and Cultural Theory*, *Medieval Aevum*, *The English Historical Review*, *International Studies in the Philosophy of Science*, *Journal of European Studies*, *Slavic and East European Journal*, and *Counterfire*, and are often awarded [book prizes](#). You can find links to reviews and awards on the individual title pages on our website, and [a list of our prize-winning books](#).
- OBP is eligible to receive European Commission's publication grants for research funded within the [FP7](#) and [Horizon 2020](#) frameworks, and we are an approved member of [OASPA](#), the Open Access Scholarly Publishers Association. We are compliant with the open access requirements of [OAPEN](#), the European Research Council, The Wellcome Trust, the Austrian Science Fund (FWF) and the

[Norwegian Register for Scientific Journals, Series and Publishers](#). Our titles are listed in SCOPUS, WorldCat (OCLC), [Clarivate's Book Citation Index](#), [BASE](#), [CERES](#), [The Publication Forum \(IUFO\)](#), [Spanish National Research Council's Scholarly Publishing Indicator](#), [ROAD: the Directory of Open Access scholarly Resources](#), and the [Directory of Open Access Books](#).

(8) Other Innovations

- We provide openly available and accessible Book-level Metrics.
- We believe Open Access publications can embrace the possibilities of digital publishing – by, for example, embedding audiovisual material or enabling greater interactivity with readers – without abandoning the printed form. While the digital elements discussed here are most easily and effectively accessed from digital editions of the book, we make it easy for readers of the print edition to make use of them by providing web links, and also scannable [QR codes](#) wherever possible.
